ORDER DESIGNATING AREA FOR FORECLOSURE SALES

Motion by Commissioner Bacon, seconded by Commissioner Robinson, to designate the South Entrance of the Courthouse (sometimes referred to as the Commerce Street Entrance) as the area for posting notices of foreclosure sales, and the South Entrance Steps as the place where foreclosure sales are to be held. This action taken in compliance with V. T. C. A. Property Code, Section 51.002; and it is further ORDERED that said designation shall be recorded in the Real Property records of Eastland County.

Upon a vote being called by the County Judge, all Commissioners voting, "Aye," order declared passed. Now therefore, it is hereby ORDERED, ADJUDGED AND DECREED that the above and foregoing action taken in open court is hereby enacted.
