A RESOLUTION OF THE EASTLAND COUNTY WATER SUPPLY DISTRICT, ORDERING A MUNICIPAL ELECTION TO BE HELD ON MAY 2, 2026 FOR THE PURPOSE OF ELECTING TWO DIRECTORS BY THE QUALIFIED VOTERS OF THE CITY OF EASTLAND; AUTHORIZING A JOINT ELECTION WITH THE EASTLAND INDEPENDENT SCHOOL DISTRICT (EISD), THE EASTLAND MEMORIAL HOSPITAL DISTRICT (EMHD), AND THE CITY OF EASTLAND; DESIGNATING THE POLLING PLACES; AND DIRECTING THE NOTIFICATION OF SUCH ELECTION

BE IT RESOLVED BY THE EASTLAND COUNTY WATER SUPPLY DISTRICT:

Section 1. That a general election is hereby ordered to be held on the 2nd day of May 2026, for the purpose of electing two (2) directors by the qualified voters of the City of Eastland.

Section 2. That the Eastland County Water Supply District agrees to hold a joint election with the EISD, EMHD and the City of Eastland to be conducted by the County Joint Elections Administrator.


