An election is hereby ordered to be held on May 3, 2025, for the purpose of:

1. Adding all portions of Eastland County, Texas, located outside of the current boundaries of Eastland Memorial Hospital District to the Eastland Memorial Hospital District.
2. The portions of Eastland County, Texas, located outside of the current boundaries of Eastland Memorial Hospital District assuming its proportionate share of the outstanding debts and taxes of the Eastland Memorial Hospital District, if it is added to the district.
